SUPPLEMENTARY DECLARATION OF TRUST

This SUPPLEMENTARY DECLARATION OF TRUST (hereinafter referred to as this "Supplementary Trust Deed") to the Declaration of Trust dated July 16, 2012 is made and executed at Hyderabad on this 13th day of May in the year Two Thousand and Sixteen ("Effective Date") by:

Ms. Reshma Haroon Lohia, D/o Haroon Musa Lohia, residing at House No: 11-2-555/2/A, near Agapura bridge, Agapura, Hyderabad- 500 018, *Aged about - 48 years.*

And

Ms. Padmavathi Koppula W/o Koppula Narsanna, resident of Flat No: 203, Sony Sai Kuteer Apts, Thyagaraya Nagar, Backside PVT Market, Kothapet, Saroornagar- 500 035, *Aged about 46 years.*

hereinafter referred as the 'trustees' which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include the Trustee or Trustee for the time being of this Trust Deed whether original or substituted, and its successors and permitted assigns).

WHEREAS

1. Originally one Ms. Valli Sulaxana and Mr. Irfan Baig had formed a trust by name 'VOICE 4 GIRLS' by way of a Declaration of Trust dated 16-07-2012, which was registered bearing document number 115 of 2012, Book-IV, in the office of the SRO, S.R. Nagar, Hyderabad, and having a Corpus Fund of Rs.5,000/- (Rupees five thousand only).
2. That the trust - 'VOICE 4 GIRLS' has been carrying on its operations successfully since its existence even till date, thereby doing the needful for the needy. That even the present corpus of the Trust is Rs.5,000/- (Rupees five thousand only).
3. The original trustees, namely Ms. Valli Sulaxana, D/o. Mr. Sri Baba Ithapu, who was also the Settlor and one of the First Trustees, and further Mr. Irfan Baig, S/o. Mirza Sultan Baig, the other of the First Trustees have resigned from the Trust, on 31-08-2013 and 30-08-2014 respectively.





4. One Ms. Reshma Haroon Lohia, D/o. Haroon musa Lohia, was appointed as a Trustee of the Trust 'Voice 4 Girls' on 17-08-2013 and one Mrs. Padmavathi Koppula, W/o. Koppula Narsanna, was appointed as a trustee of the Trust – 'Voice 4 Girls' on 23-08-2014, and they both have been acting as Trustees of the Trust since the date of their appointment even till date, thereby carrying on the operations and looking after all the affairs of the Trust.
5. That the present address of the Trust is H. No. 10-2-9/18/D, Income Tax Tower Lane, A.C.Guards, Saifabad, Hyderabad -500 004 with effective from September 01, 2014.
6. The Trustees had resolved to amend certain clauses in the said Trust Deed for better implementation of the objects and realisation of the true spirit and purpose for which the Trust was formed, and had approached the Court of Law for Amendment of the Original Declaration of Trust dated 16-07-2012, vide O.S. No. 356 of 2015, before the hon'ble III Additional Chief Judge, City Civil Courts at Hyderabad and the said Court had decreed the said suit vide its orders dated 27-01-2016, thereby granting permission to amend the original Trust Deed / Declaration of Trust dated 16-07-2012, and in furtherance of the same, the present Supplementary Trust Deed is being executed.

NOW THIS SUPPLEMENTARY TRUST DEED / AMENDMENT TO THE REGISTERED DECLARATION OF TRUST BEARING THE DOCUMENT No. 115/IV/2012 WITNESSETH AS FOLLOWS:

- I. THAT the Existing clause 4 of the registered Declaration of Trust dated 16-07-2012 shall be substituted and replaced with the following variations/amendments to read as under:

The objects of the Trust shall be to serve the public at large without profit motive in particular to support girls from low-income households in accessing primary and secondary education, vocational training and gaining employment. The Trust shall pursue without profit motive any or all of the following modes or any other mode incidental thereto:

- a. To liaise with school authorities for introducing gender empowerment/ life skill curriculum with the purpose of encouraging equality between girls and boys.
- b. To impart training to teachers, college students, counsellors, parents and school authorities in the use of interactive teaching techniques, methodologies, aids and other such materials.
- c. To work with parents and the wider community to ensure that a supportive atmosphere is created at the household level and community level for encouraging girls to attend schools.

- d. To organize, start, run or assist any charitable programme either by itself or by assisting or coordinating with other educational or other institutions for teaching, guidance and counselling, vocational training or training for enhancement of the employment prospects for girls and young women.
- e. To conduct workshops, charitable programs, seminars etc. for adolescent girls and boys from low-income households, in coordination with other organizations.
- f. To work with partners/associates to develop, design, implement and monitor charitable programmes for adolescents.
- g. To provide guidance and technical support to the government and other partners for adolescent girl charitable programmes.
- h. To undertake these and other incidental activities without profit motive which are consistent with the above objects.
- i. The moneys disbursed for the purposes of education in pursuance of the above objects will be confined to Indian shores.
- j. If any of the above objects is found to be inconsistent with the objects of a public educational and charitable institution under any of the provisions of the Income-tax Act, 1961 or any other law applicable to such trusts as now enacted or as may be enacted or amended at a future date, the objects stated above will be treated as so modified to accord with such law so that any concessions, privileges, conditions or regulations available and applicable to public educational institutions will be available or applicable to this Trust as well, so that this Institution will continue to retain its character as a public educational and charitable institution without profit motive with public character within the meaning of the provisions of the Income-tax Act, 1961 or any other law.

II. THAT the Existing clause (g) of the sub-heading 5 of the registered Declaration of Trust shall be modified and amended and be replaced with the following Clause (g) of the sub-heading 5:

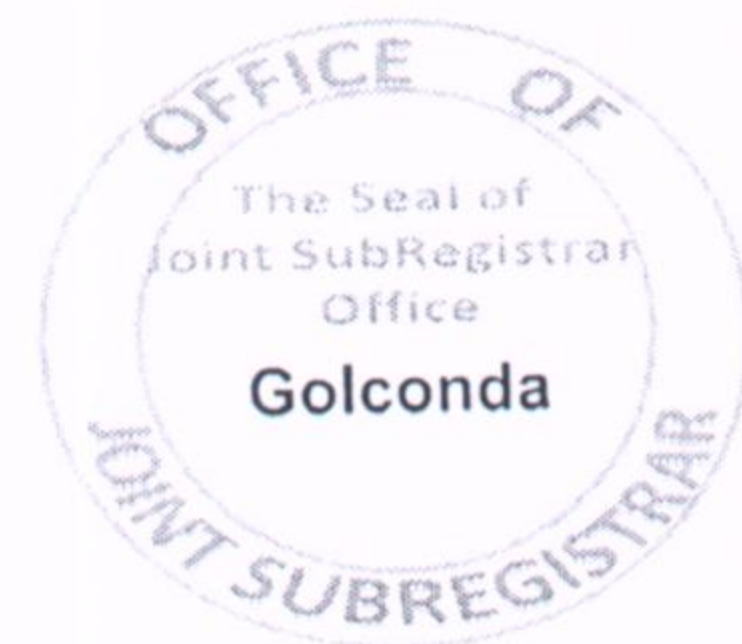
(g) The trustees will not be entitled to any remuneration, except a right to remuneration for specific services and expenses actually incurred in discharge of their duties as Trustees. Further, no payment shall be made to trustees/members by way of profit, interest or dividend.

III. THAT the Existing clause (b) of the sub-heading 6 of the registered Declaration of Trust is to be replaced by the following clause (b) and after the clause (j), the following additional Clauses (k), (l), (m), (n), (o), (p) be inserted as clauses under the sub-heading 6:

(b) The Board of trustees shall have the power to apply the whole or any part of the Income of the trust or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time. However, Subsequent to registration of the Trust with Income Tax Department under section 12A or under section 80G of Income Tax Act, 1961 (or other similar sections) Board of Trustees shall have the power to invest the Trust Funds only in the modes specified under the provisions of section 13(1) (d) r.w. Sec 11(5) of the Income Tax Act, 1961 or as per the directions given by Director / Chief Commissioner / Commissioner Exemptions from time to time and to alter, vary or transpose such investments, from time to time at the discretion of the trustee / Trustees within the approved list.

(k) To convert and deal with the trust property and/or any investments of the trust.

(l) To Borrow or raise or secure payments of moneys.



(m) To establish office of the Trust at such place or places and to shift the office of the Trust to such other places from time to time as they deem fit.

(n) To join cooperate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

(o) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India which may have been established or which may hereafter be established for similar charitable purposes mentioned in these presents or any of them to enable such institution, societies, organisation or Trustees to start maintain or carry out such charitable objects.

(p) To apply to the Government, public bodies, urban, local, municipal, district and other bodies corporation, Companies or persons for and to accept grant of money and of aid, donations, gifts subscriptions and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

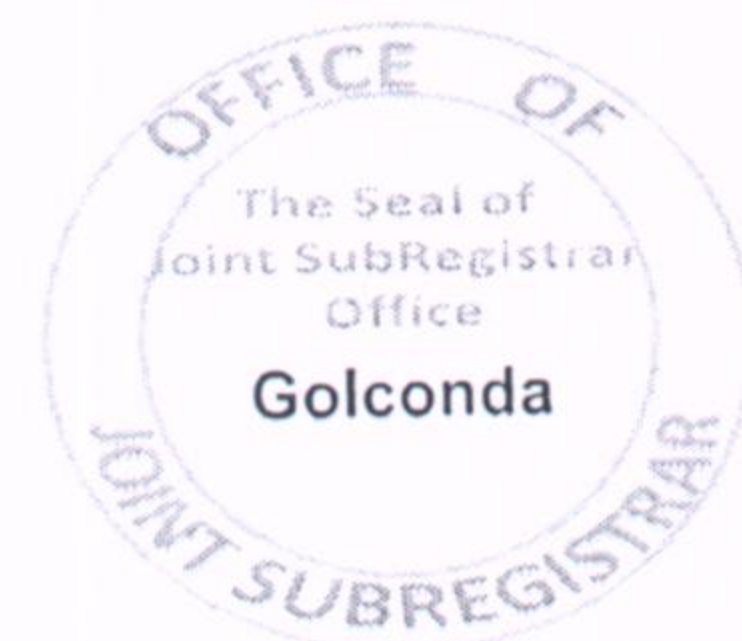
IV. THAT the following clause (b) be inserted under the sub-heading 14:

(b) The Trust and Trust Funds shall be irrevocable for all times and shall continue in perpetuity.

V. THAT the following clause be inserted as the sub-heading 16:

16. AMENDMENTS TO TRUST:

It will not be open to the Trustees to amend objects or the terms stipulated in the Trust Deed frequently. However, if any amendment is necessary for more effective implementation of the objects or for carrying on the operations of trust more efficiently or to bring more clarity to the objects of the trust, it shall be made with the consent of not less than 3/4th Trustees then serving on the board. However, No amendments to the trust deed/memorandum of association/bye laws/ rules and regulations shall be made which may prove to be repugnant to the provisions of Sections 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961, now or as amended from time to time. Further, no amendment shall be carried out without the prior approval of Commissioner of Income tax/Chief Commissioner of Income Tax / Director of Exemptions or any other concerned authority under direct tax laws.



VI. THAT the following clause be inserted as the heading 17:

17. BENEFICIARY OF THE TRUST:

The benefits of the Trust shall be open to all irrespective of caste, creed or religion.

VII. This Supplementary Trust Deed shall amend and alter the Trust Deed to the extent set out herein and shall form an integral part of the Trust Deed. The Trust Deed as amended by this Supplementary Trust Deed shall come into force from the Effective Date; and, all references to the Trust Deed in the Fund Documents shall be construed as a reference to the Trust Deed so amended by this Supplementary Trust Deed.

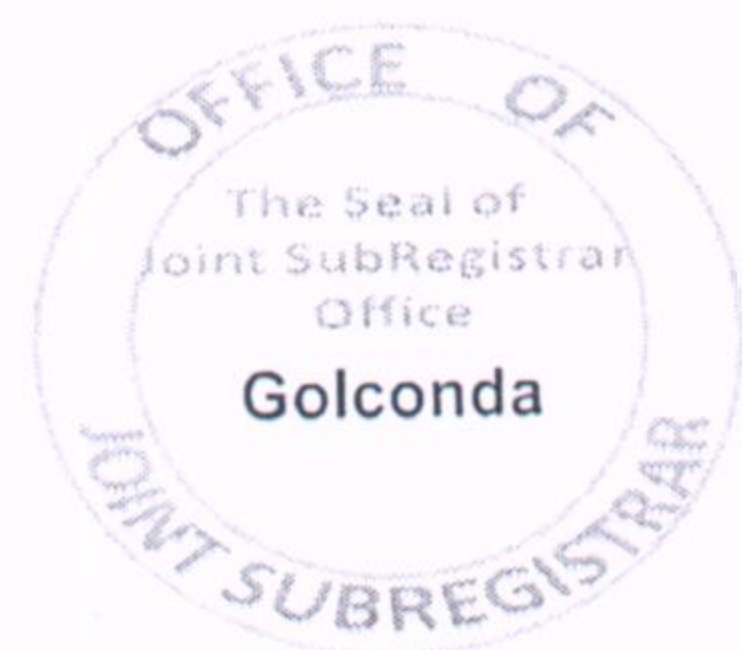
VIII. The Trust Deed as amended by this Supplementary Trust Deed shall remain in force and binding upon the Trustees.






